

Payment Terms - In addition to the provisions of Section 4.2.1 of the General Terms, the following shall apply:
Unless otherwise agreed to in writing by DS, Customer shall pay all invoices by wire transfer within thirty (30) days from the date of invoice.

Late Payments - In addition to the provisions of Section 4.2.2 of the General Terms, the following shall apply:
Customer shall pay interest for late payment at a rate of 15% per annum or highest bank rate on all funds unpaid at the due date, plus reasonable attorney fees and costs incurred by DS in collecting unpaid amounts.

Taxes - In addition to the provisions of Section 4.2.3 of the General Terms, the following shall apply:
All prices are exclusive of taxes. Customer shall be responsible for payment of any and all taxes, including but not limited to, sales, excise, on import or otherwise, or similar charges of any nature whatsoever, now in force or enacted in the future, that are levied, assessed, charged, withheld, or collected for or in connection with the transfer or usage, in the extent authorized hereunder, of the DS Offerings provided hereunder or otherwise arising in connection with the Agreement, but excluding domestic taxes based on DS's net income.






